The Goleta Water District (GWD) is offering rebates for upgrades to irrigation systems and landscaping to increase water efficiency. **PROJECTS MUST BE APPROVED IN ADVANCE. THE PROGRAM IS NOT RETROACTIVE. LANDSCAPES FOR NEW CONSTRUCTION ARE NOT ELIGIBLE.** Sales receipts and/or contractor invoices are required for all rebates. With the exception of pre-approved design services, only the retail cost of material will be rebated. This is a performance based rebate program. The project must result in a net reduction in total landscape water consumption for the site.

How Much Is The Rebate?

The program covers a portion of the cost of pre-authorized irrigation equipment and landscape materials.

- **Design:** 50% of the cost of landscape or irrigation design services, up to a maximum of \$250 per site.
- **Irrigation Equipment:** 50% of the cost of drip irrigation parts, sprinkler system efficiency retrofits, sprinkler nozzles (delivering 1"/hour or less with proper pressure), pressure compensating heads, pressure regulators.
- **Water Wise Plants, Mulch, and Permeable landscape material:** 50% of the cost of water wise plants, mulch. Permeable landscape to include gravel, cobbles up to 4", flagstone or similar with a minimum of 4" spacing. Synthetic turf is no longer eligible. Planted areas must be covered with a 3-inch layer of mulch. Hardscapes and pathways, including decomposed granite, are not eligible.
- **Smart Irrigation Controller:** 50% of cost of a smart irrigation controller. Smart irrigation controllers work on a simple principle: automatically adjust for weather changes, and irrigate based on the needs of your plants.
- **Pool Covers:** 50% of the cost of a pool cover, up to a maximum of \$300 per pool cover.

Any combination of items above may qualify for a rebate amount of \$2,000 per meter serving irrigated area (up to two meters) for accounts classified as landscape irrigation, commercial and multi-family (including HOAs).

TERMS & CONDITIONS

1. The Smart Landscape Rebate Program now has a fully electronic submittal process. Please read and follow the steps in the Application Addendum for the Electronic Application Submittal Process.
2. The **Applicant** applying for the rebate(s) **must be a Goleta Water District customer.**
3. **Only Pre-Qualified Equipment** as determined by a GWD staff member, upon verification of anticipated water savings, shall qualify for a one-time rebate after installed up to a maximum of \$2,000 per meter, up to 2 meters.
4. All Pre-Qualified Equipment as detailed on Page 2 of this application is **valid for 120 days** from the **AUTHORIZATION TO PROCEED** date.
5. The purchase and installation of all equipment denoted by GWD staff under the heading of "Pre-Qualified Equipment" must be installed within 120 days of the **AUTHORIZATION TO PROCEED** date.
6. The reverse side of this form must be signed and returned after Pre-Qualified Equipment is filled out by GWD staff.
7. After project is completed, applicant must electronically submit itemized, legible copies of the valid, dated sales receipts for materials-only to qualify. Labor does not qualify for rebate.
8. Rebates shall be on a one-time basis per address or customer.
9. "Before" and "After" photographs of the project area taken from the same angle are required to be submitted.
10. Post-Installation Items including a) itemized receipts detailing specific items for rebate and b) "After" pictures of the project taken from the same angle of the "Before" pictures, must be received by GWD prior to the **ELECTRONIC SUBMITTAL DEADLINE.**
11. The Goleta Water District is not responsible for any tax liability which may be imposed as a result of payment of any rebates. The Goleta Water District is not providing tax advice, and any communication by the Goleta Water District is not intended or written to be used, and cannot be used, for the purpose of avoiding penalties under the Internal Revenue Code.

Note: **Rebate amounts are subject to change without prior notice and based upon availability of funds**
