- Goleta Water District (GWD) will rebate the cost of up to two deliveries (7-10 yards) of screened or unscreened mulch from County of Santa Barbara South Coast Recycling and Transfer Station at up to \$80 for each delivery.
- A maximum of two delivery receipts may be submitted for rebate for delivery dates within the same fiscal year (July 1 through June 30) with the maximum rebate of \$80 each or \$160 for the two deliveries. **Proof of purchase is required for all rebates.**

### STEPS/CHECKLIST TO APPLY

- Call South Coast Recycling and Transfer Station at (805) 681-4981 to schedule a mulch delivery.
- Have your mulch delivered, obtain an invoice from the County of Santa Barbara, and pay the County of Santa Barbara for the delivery. Save the invoice and proof of purchase/payment.
- Complete and submit an electronic copy of 1) this application, 2) SB County mulch invoice, and 3) proof of invoice payment (to the County of SB) by email to: [conservation@goletawater.com](mailto:conservation@goletawater.com). A JPG picture or scanned PDF copy of the three application materials is acceptable. Application materials must be emailed within 60 days of invoice date. GWD staff will reply by email to confirm that your application materials were received.
- Once submittals are verified, rebate checks will be issued in approximately 30-60 days. Questions? Call (805) 964-6761.

### TERMS & CONDITIONS

1. Failure to comply with these terms and conditions are automatic grounds for disqualification from the program.
2. The person applying for the rebate(s) must be a Goleta Water District single-family, multi-family, commercial, or landscape irrigation customer and mulch delivery must occur at the service address of the account holder.
3. Only mulch from the **County of Santa Barbara South Coast Recycling and Transfer Station shall qualify** for up to \$80 rebate per delivery of screened or unscreened mulch per property and/or site as determined by a Water Conservation staff member, after delivered and paid in full by the customer.
4. Mulch invoice, proof of payment, and application must be submitted within 60 days of the SB County invoice date for this application to qualify. Application may be selected for inspection of mulch delivery by Goleta Water District staff. If selected, I understand an inspection will be required before rebate is paid.
5. Complete and submit 1) this application 2) SB County mulch invoice, and 3) proof of payment by email to: [conservation@goletawater.com](mailto:conservation@goletawater.com). Application materials must be submitted within 60 days of invoice date. A JPG picture or scanned PDF copy of the three application materials is acceptable. GWD staff will reply by email to confirm that your application materials were received. GWD is not responsible for items not received by email. Applicant must attach a legible copy of the valid, dated mulch delivery invoice or receipt for this application to qualify.
6. Rebates shall be on a two-time basis per delivery date per address or customer per fiscal year (July 1 – June 30) with no more than \$80 rebated for each delivery and \$160 rebated for up to two deliveries within the same fiscal year.
7. The Goleta Water District is not responsible for any tax liability, which may be imposed as a result of payment of any rebates. The Goleta Water District is not providing tax advice, and any communication by the Goleta Water District is not intended or written to be used, and cannot be used, for the purpose of avoiding penalties under the Internal Revenue Code.
8. Note: **Rebate amounts are subject to change without prior notice and based upon availability of funds.** Rebate Terms and Conditions are subject to change without prior notice. Rebates are issued on a first come, first served basis and are subject to availability of funds. Offer void where prohibited or restricted by law.
